9.1b A Life Member is a person who has given service to P.A.C.I.F.I.C.A. continuously for not less than a period of fifteen years in total and is sixty years of age or over at the time of being nominated for Life Member status, honoured for highly valued services to P.A.C.I.F.I.C.A. and elected as a Life Member by resolution of a General Meeting passed by a two-thirds majority of those Members present and voting. A Life Member shall have all the rights and privileges of a financial Member and shall be subject to all the duties of a Member except those of paying membership subscriptions and levies.
